NEW MEMBERSHIP

- Annual membership dues are for the fiscal year January thru December.

- There is a \$25.00 application fee applied to all new member applications.

ANNUAL MEMBERSHIP RENEWALS

- Membership renews on January 1st of each year. Invoices are mailed in December with net 30 terms.
- Termination of membership occurs when renewals are not paid in full.
- Exceptions can be made to allow members to pay in three installments, in which case dues are to be paid in full on or before march 31st. Be sure to talk with the chamber office to make payment arrangements.
- Applications are to be submitted to the board each month for review.
